Are you being charged "city sales tax" while not living inside city limits?

Some of Willow Creek Estates is not with-in the city limits, and some of those residents are being charged "city sales tax" and "franchise tax" on their utility bills and cell phone bills. The City of San Marcos Planning & Development Services Department can give you documentation to verify that your address does NOT reside inside the city limits. You can then present that documentation to those companies that are incorrectly billing you to remove the taxes from your bills and give you reimbursement of past charges. Some of the utility companies are great with the removal and reimbursement but some companies are harder to deal with. Below is a letter that one of our Directors, Dave Bethancourt recently sent to our state Comptroller, Susan Combs, requesting they fix a map on their web-site that most of these companies follow for whom to charge city tax and franchise fees. The Comptroller's office has stated their map will be fixed and updated by 11/25/2010.

Susan,

I own my home at 715 Willow Creek Circle, San Marcos, TX. According to your Tax Rate Locator website (<https://ourcpa.cpa.state.tx.us/atj/addresslookup.jsp>) I am within the city limits of San Marcos. This came to light after I noticed I was billed for city sales and franchise taxes on my IESI garbage bill. I spoke with Nicole and she was nice enough to correct their mistake and when I mentioned I would put a note about this on our homeowners website called back to correct all the addresses in the neighborhood.

We have not been in the city since we were disannexed in 2003. I live in the Willow Creek Subdivision half of which was disannexed. I didn't check every address but of the ones I checked that are not in the city all are shown to be. I also checked the three other subdivisions that were disannexed, Laurel Estates, Turkey Hollow, and Quarry Springs. Every address I checked showed to be in the city. Those three subdivisions were disannexed in their entirety.

I would appreciate it if you would correct your website as this is imposing an illegitimate tax on these individuals along with a lot of work in correcting billing amounts. After a little research I found that many of the corporations are not as easy to correct your and their mistake as IESI.

National Neighborhood Night Out is an annual event that encourages neighborhoods to stage block parties, for the purpose of fighting neighborhood crime and getting to know and to look out after each other. There is a Neighborhood Watch Program in Willow Creek and this event is planned and organized by these residents. Willow Creek is broken up into many different "blocks" and each has a block captain to help get the word out if there is a concern for the group, or to bring any concerns to the attention of law enforcement or the HOA. Do you have a dispute with one of your neighbors?

In January, the new Hays County Dispute Resolution Center (HCDRC), a non-profit organization, opened in San Marcos. The purpose of the center is to facilitate problem-solving for individuals and organizations in Hays County by providing, promoting and teaching effective methods of conflict resolution through mediation.

The center is working with the San Marcos Police Department, the Hays County Sheriff's Office, and Animal Control to offer free mediation services to private parties who are in dispute and are referred to the HCDRC by a law enforcement agency, Animal Control, or a neighborhood association.

If you have a dispute with a neighbor over such things as, barking dogs, fences, trees, lights, loud noise or any other issue that police or Animal Control is unable to resolve, you may want to try mediation (free of charge) to help.

Mediation is a proven process to allow parties to sit down in a safe environment and communicate to promote reconciliation, settlement or understanding. It's fast, it's convenient, it's informal, it's confidential, and the parties are in charge of the outcome.

Mediators are carefully trained and screened. They come from a variety of backgrounds including law, business, psychology, religion, education and social services. All of them are certified by the Texas Mediators Credentialing Association and volunteer their services to the HCDRC.

Many cities in Texas, including Austin, San Antonio and Houston have Dispute Resolution Centers. Approximately 75%-85% of all the cases that are mediated at Texas Dispute Resolution Centers are resolved with a mutually satisfactory agreement. Many of those cases are referred by the courts.

So if you have a problem with a neighbor, call any board member and ask for a referral to the HCDRC. The HCDRC will discuss the problem discretely with you and advise whether or not mediation is right for your situation. They will also make the effort to get the other party involved in the process. Since it is confidential, no one will discuss your issue with any one else without your consent.

Residential Free Bulky Items Waste Pick-Up Tips

The City of San Marcos provides this service for city residents. Free bulky waste pick-up (furniture, appliances, yard waste) may be scheduled for your collection day the 1st and 3rd full weeks of the month by calling 512-393-8026 by 2:00 p.m. the previous business day. Branches must be cut to 4-foot lengths, tied and bundled, weighing no more than 35 pounds; branches that are not tied and bundled will NOT be picked up. Bulky waste includes old furniture, hot water tanks, mattresses, etc. (Try to donate to a charity if your unwanted items are still usable.) Trees, shrub and brush will also be picked up.

Bulky items that will NOT be picked up:

- *Tires, rocks, bricks, and dirt.
- *Tree stumps or branches larger than 5 inches in diameter or longer than 5 feet.
- *Appliances containing Freon not tagged by a licensed technician.
- *Hazardous waste.
- *Construction debris generated from commercial remodel or demolition.
