

## Traffic Flow on Stagecoach Trail:



Several residents have expressed to WCHOA board members and San Marcos city officials that traffic delays are regularly occurring on Stagecoach Trail during school days. These traffic problems occur on school day mornings and afternoons due to parent's dropping off and picking up students at the Hernandez Elementary School. Some members of your Board have met with city officials to resolve this traffic flow difficulty, since it could have serious implications for emergency vehicles in addition to the inconvenience of our residents.

After considering several possible options, we came to agreement that one of two ideas have merit. Thus, we are now canvassing our neighborhood residents to find out which alternative is most acceptable to you:

Option 1: First, is to use immediate available funds and realize minimal cost, the Stagecoach Trail and Snyder Hill Drive intersection could be converted to a generic roundabout by using signage, paint, and asphalt curbing. Some of the Stagecoach Trail curbing near the school will be trimmed to street level so emergency vehicles can proceed regardless of traffic conditions. The city staff will contact Hernandez School officials so that they can encourage their parents/guardians to use the roundabout to form an east bound line for drop off or pick up rather than making U-turns or left turns which block west bound traffic. Such a roundabout can be constructed very soon and may or may not alleviate much of the problem. Then, for the long run, the city staff will request funding for a new CIP project to modify the roundabout to a more permanent structure that would extend the westbound double lane of Stagecoach Trail to Snyder Hill Drive. This funding is likely to take 3 to 4 years before the work can be done.

Option 2: Or second, do not convert the Stagecoach Trail and Snyder Hill Drive intersection to a roundabout. Request that the city still trim the curbing and obtain funding for a project to extend the westbound double lane of Stagecoach Trail further to Snyder Hill Drive, understanding that the latter is likely to still take 3 to 4 years before the work can be completed.

We need to hear from our residents. As a board we take our responsibility very seriously and want to do what is best. # WCHOA Annual Spring Garage Sale - March 30th & 31st:

# Simplifying the Dues Year:

Many of our residents have asked that we consider making our dues year the same as the calendar year. The Board listened and at the December 2011 WCHOA Board meeting, our Board approved a change in the annual dues year.

- ➤ What does this simplification really mean? Well, rather than having that crazy June 1st thru May 31st dues year which confused all of us including the Treasurer who had to keep track of the mid-year stuff our dues are now collected on a calendar year basis. This change went into effect beginning in 2012.
- ➤ How will this affect me? For those of you who have already paid your dues for the current year, this means that you are paid through December 31<sup>st</sup> and you won't have to pay again until January. What a bargain! You are getting an extra half of year at no additional cost.
- What if I have paid for future years? If you were one of the residents who paid ahead to beat the dues increase that went into effect on January 1st, your dues will be paid through December 31st of whatever year(s) you paid for.
- ➤ What if I haven't paid my current year dues yet? You will also be getting a bargain! In the past, if you paid your dues right now, you would have only been paid through May 31st, but if you pay now, you will be paid through the end of the calendar year.

As you can see, there are no losers with this change and there will be a lot less confusion. The members of the Board think that everyone will be pleased with the change.

#### We Need You:

For the current year to date, we have a total of 195 paid households -- that's 41% of the 475 property owners in Willow Creek. **WCHOA** really needs every homeowner's support....and this means YOU. Our collective efforts with the potential for over 475 households working together can continue to make our neighborhood the prettiest and safest in San Marcos. We need to stand together to enhance property values, limit criminal activities, and make the neighborhood pleasing for all our inhabitants. #### Hays County's Formula for Success is Working

As we begin the New Year, I am pleased to report on the progress that Hays County made during 2011. Our county government has developed a simple formula for success, informed by time-tested principles of commonsense and responsibility. We must keep taxes low, manage our money wisely, and have the foresight to prepare for the future. Over the past year, we have adhered to these principles and they are producing good results.

In 2011, we balanced the county budget without raising taxes and placed Hays County on its strongest financial footing in history. Our county's savings account continues to grow, now topping \$30 million. Our credit rating has improved to "AA," one of the highest ratings available to county governments.

We also made important improvements to roads and transportation. In 2008, our citizens voted to make a \$207 million long-term investment to improve our county's outdated and increasingly unsafe road system. This marks our first major road improvement initiative in more than half a century. This investment is making our roads safer and more efficient, and protecting our quality of life for future generations. In the past year, we moved forward on many road projects and secured state and federal approval for others. Through good management practices, we are accomplishing these projects under budget. I was also able to negotiate a \$133 million reimbursement from the State of Texas to Hays County taxpayers to further offset the cost of these projects. As we look forward to 2012, we will continue to make Hays County's roads among the safest and most efficient in Texas.

We also made important advances in consolidating county facilities to improve efficiency while meeting the needs of a growing county. The Commissioners Court worked together with newly elected Sheriff Cutler to make important repairs to our jail facilities. We are also completing the new government center project well under budget. This will save taxpayers millions of dollars by consolidating many county departments under one roof while also preparing for the county's future growth.

These accomplishments highlight a busy year that also saw important advances in public safety and securing a long-term water supply. Together with our cities, state university, and local employers, Hays County's star is rising. Our thrift and fiscal responsibility, along with investments in roads and infrastructure, make Hays County a great place to live, raise a family, and start a business. In fact, CNN Money recently honored Hays County for the third highest rate of job growth in the nation.

Our federal government would do well to follow the Hays County model of low taxes, sound management, and preparation for the future. This has been our formula for success in the past and it will continue to work into the future.

#### **Engaging Citizens in City Budgeting and Planning**

We were delighted to see so many Willow Creek residents turn out on Feb. 2 at the Activity Center for the City's Open House to evaluate City services. Your views on essential city services such as Police, Fire, Transportation (Streets, Roads, Sidewalks, Etc), Library, Parks & Recreation and our Future Water Supply will help guide the direction of the City of San Marcos as we plan future budgets and programs.

We are holding nine "Level of Service" open houses in January and February as a way to inform our citizens about the features and quality of our services—and how we compare with other communities. We are confronted by the reality that spending growth is outpacing revenues. So we have to investigate cost controls, efficiencies and if necessary, ways to increase revenues to meet community needs.

At the open houses, citizens are able to review poster boards with summary information, visit with and question staff about services, and then fill out a survey that will show you how various levels of services will affect your pocketbook. You may also add your comments and suggestions.

We will also put the survey online for two weeks following the last public Open House in mid-February for those who haven't been able to attend a session. We have all of our poster board presentations available now at <a href="https://www.sanmarcostx.gov">www.sanmarcostx.gov</a> for you to review.

At the end of the process, this information will be summarized and utilized as the City Council begins its budget process and long range planning.

Thank you for staying involved in community issues. The City Council and staff depend on your active participation as we strive to meet your expectations for strengthening the San Marcos community for the future.

# Capital Area Council of Governments Emergency Notification System

#### Overview:

The CAPCOG Homeland Security and Emergency Communications Divisions are working together to implement the Emergency Notification System (ENS). ENS is an automated phone-dialing tool that enables authorized public safety personnel in the CAPCOG region to notify residents in an emergency situation. Residents are called only when property or human life is in jeopardy. The ENS system calls a small number of area homes and businesses (hundreds to low thousands) using the telephone numbers and addresses maintained by the 9-1-1 system. The ENS system can be used to contact citizens by cell phone if they register their phone number on the CAPCOG ENS Cellular Phone registry. The ENS system is also used to notify emergency response groups, disaster recovery planners, and other contact groups in the event of an emergency. Messages are distributed to people via phone and email. ENS is PC-based and uses multiple phone lines to notify people. The system was implemented using Homeland Security Grant Program funds and funds from participating local governments.

#### Cellular Phone Registry:

Through a web-based application, residents may enter their name, cellular telephone number, and attach one or more locations to that number in order to get important public safety messages. Residents can go to the website at <a href="http://wireless.capcog.org">http://wireless.capcog.org</a> and follow the instructions to add their information into the ENS cell phone registry.
