Since August, we have met with dozens of community groups, small and large, from neighborhoods to civic clubs, high school and university students, retirees, businesses and institutions. Our conversations are aimed at asking a few questions and listening closely to the answers from our citizens.

We also have used a unique online resource on the City website (www.sanmarcostx.gov/ideas) called "IdeaScale." You can register online, submit your ideas, and vote other ideas up or down. The most popular ideas rise to the top. I encourage you to get online and participate in this process. It's interesting and enlightening to see what views our community members have for the future.

The "visioning" step in this Comprehensive Master Plan will culminate on October 15 at the Arts and Eco Fest at the courthouse square. In addition to enjoying the Farmers Market, live music, and the festival, you will be able to visit the Dream San Marcos booths and further express your ideas.

In the coming months we will meet with the major institutions in San Marcos—Texas State University, San Marcos CISD and Hays County to talk about our common goals and vision for San Marcos. We'll explore jobs, education, infrastructure, growth, transportation, downtown and what our boundaries might be in the future.

These discussions will move into policy development continuing in concert with you and other citizens that will help us shape our 10 year Comprehensive Plan, which guides development, infrastructure, zoning and the growth of San Marcos.

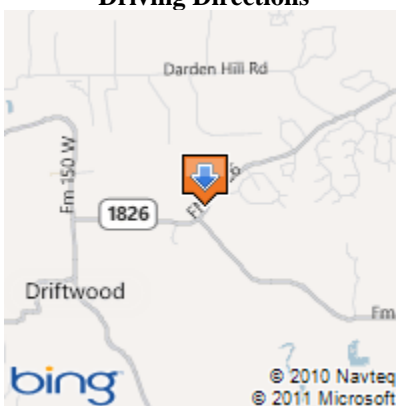

WCHOA Reminders

- WCHOA dues will increase to \$20 per year on January 1, 2012.
- Other WCHOA Annual Events:
 - Spring Neighborhood Clean-Up – date to be announced by the City.
 - The first Saturday in April is the Neighborhood Garage Sale.
 - The first Sunday in June is the Annual General Membership Meeting.
- It is a violation of city code to park vehicles in the yard.
- It is both a city and county violation to allow unleashed dogs to run loose in the neighborhood.
- Easements on all lots should be kept cut and debris removed.
- Contact any HOA director or officer (list on page 1) if you have issues or questions.
- Please be careful when driving through our community.....keep your speed at 30 mph or less and always come to a complete stop at all our stop signs. You may report speeding or reckless drivers to the Hays County Sheriff Department or the San Marcos Police Department. Keep in mind that many of our residents (including youngsters and senior citizens) use our roads every day for walking, jogging, and bike riding. Reckless driving endangers everyone.
Please be safe and not sorry.

Use Caution

A quick reminder to be cautious when strangers come calling at your door uninvited claiming to be vendors, solicitors, salesmen, or whatever. Exercise caution with a healthy dose of skepticism to protect yourself and your wallet. Know exactly what you are buying or what "cause" you are asked to financially aid. Well organized canvassers, possibly of dubious intent, sometimes saturate an area with their efforts one day and are long gone the next. Be wary of someone claiming to need help. Make a telephone call for them or retrieve an item from inside your home, but have them wait outside (with your doors locked). Check your doors and windows locks after you've had repairmen or delivery men in your home. Even though we live in relatively secure community, some due diligence on our part is always smart.

From the Treasurer's Corner

A strong financial position is based on strong membership numbers. And for the year that ended on May 31, 2011, the Association had 208 paid members – a little over 43 percent of eligible households. Of course, there were some changes, based on new neighbors moving in and some old friends relocating, but even in the face of a difficult economy, community members recognized the advantage of joining together to help build an even better Willow Creek. Our goal is to have at least half of our residents being active members of the WCHOA and right now we have 152 paid members for the current year.

Dues for the current year are still only \$15 per household if paid before December 31, 2011. After the end of the year, the dues will increase to \$20. Membership is a real bargain in terms of value as we work to provide more services and activities for residents and families. It is okay to pay ahead. You may pay dues for future years at the current \$15 rate until the rate increase goes into effect on January 1, 2012.

The Board feels that we need to raise approximately \$3,500 in matching funds in order to begin the construction of the two additional entrance signs (on Reimer at Philo Street and on Great Oaks Drive near the water tower). To date we have approximately one-fourth of the matching dollars needed to begin construction. A little math tells us that just getting 50 donations of \$50 (or 100 donations of \$25 or 225 donations of only \$10) would get us to our goal. **COME ON FOLKS – WE CAN DO IT.** Or are we going to have to stand out at the corner with a bucket and solicit donations as you come into the subdivision?
