## News from the HAYS COUNTY FIRE MARSHAL'S OFFICE:



### Holiday Safety Tips

#### Check it Twice for a Safe Holiday Season!

When purchasing an artificial tree, look for the label "Fire Resistant." When purchasing a live tree, check for freshness. A fresh tree is green, needles are hard to pull from branches and when bent between your fingers, needles do not break. The trunk butt of a fresh tree is sticky with resin, and when tapped on the ground, the tree should not lose many needles. Set up the tree away from fireplaces, radiators or portable heaters. Cut a few inches off the trunk of your tree to expose the fresh wood. This allows for better water absorption and will help keep your tree from drying out and becoming a fire hazard. Be sure to keep the stand filled with water.

Check your lights before decorating.

- Make sure all holiday lighting has a label that says it is "UL listed". If it doesn't have this label, the lighting is not safe to use.
- Use only light sets marked as "indoor" or indoor/outdoor" inside buildings.
- Make sure all light strings have bulbs in each socket.
- Keep all lights away from combustible materials such as fabrics or paper decorations.
- Don't connect more than three strands of lights to one extension cord.

Extension cords *can* be used with holiday decorations as long as the decorations are taken down within a few weeks.

Make sure all light strands and electrical cords are free of cuts, crimps, cracks or repairs. Never use a "three-prong-to-two-prong" plug adaptor to by-pass a grounded plug. Keep all electrical cords out of traffic areas, and not under rugs, through doorways or taped to the floor. Conserve electricity and prevent electrical fires. Turn off all lights, appliances and other electrical equipment when you go to bed or leave the house. Make sure all lit candles are in stable holders and placed where they cannot be easily knocked over or reached by children or animals. Do not leave the house with candles burning.

Never put wrapping paper in a fireplace. It can result in a flash fire, throwing off dangerous sparks and embers and may result in a chimney fire. Make sure your smoke detectors are working properly. Never remove batteries from a smoke detector to place them in children's toys. Test them monthly and keep them clean and equipped with fresh batteries at all times. Know when and how to call for help. Remember to practice your home escape plan.

### ***Loose Dog Alert!***

In either Hays County or the City of San Marcos this should never happen. A dog running loose in any part of Hays County is breaking the law – and so is its owner. Plainly said, if you own a dog in Willow Creek it must be restricted to a fenced area on your property or tethered appropriately to confine it on your property. And when walking your dog(s), they should always be on a leash and not allowed to roam freely. These same rules apply to the dogs of visitors in your home. No exceptions!

On a sad note, a little dog was struck by a car and killed on Summit Ridge recently. The dog was running loose. This is traumatic for the dog's family and also for the driver. We encourage all pet owners to keep your dogs safe in your yard or house or on leash when outside. We also encourage all drivers to observe the proper speed limits so that accidents might be averted.

### ***Fireworks & Pets:***

We want to remind all residents that it is against city code to use fireworks within the city limits and also in the ETJ (Extraterritorial Jurisdiction) which includes all of the Willow Creek Estates subdivision. Not only do fireworks pose a serious danger to the safety of persons and property, it may be

very frightening to our pets. Residents are encouraged not to engage in this activity and to also make sure that their pets have a safe and secure indoor place on New Year's Eve so they don't become spooked and run away. We have had many violations over the last few years and it's a dangerous way to celebrate. Be considerate. If you must use them, go to a sanctioned location; please do not use your backyard.

### ***E-mail Address – Stay in the Loop:***

**If you have an e-mail account**, it's in your best interest to let us know what it is so we can keep you aware of what is going on in the neighborhood in a more timely manner since email is our primary means of communicating with residents. We use your e-mail address to distribute the **Newsletter** and to put out alerts you need to know about such as vandalism, scam artists, thefts, and lost or found pets. We only use your e-mail address for neighborhood business and your e-mail address will NOT be shared. ## ***News from the City:***

### **Looking Forward to an Eventful Year**

This has been an eventful year full of both opportunities and challenges: We're rewriting our Land Development Code, finishing our Downtown Reconstruction Project and filling executive level positions that deal directly with issues of immediate concern to many people in the public.

As I approach my first year as City Manager, I want to thank the citizens and City Council for their active guidance and participation in our community—and the dedicated City employees who execute that guidance and make our visions for the community come to life. I wanted to touch on a couple of specific items and projects that may be of particular interest to you:

#### ***Stagecoach Road***

The Stagecoach Road widening project in front of Hernandez Elementary that was scheduled to begin in December has been postponed for design changes to maximize water quality in the area of the project.

The project is now scheduled to begin in late spring or early summer of 2015 to coincide with San Marcos CISD summer break. For more information on this project, please call project manager David Rabago at 512.393.8140.

#### ***Code SMTX***

Our Planning and Development Services Department is hard at work on Code SMTX, the citizen-driven rewrite of our land development code.

City planners and outside consultants received a great deal of resident comment and guidance during public sessions in October 2014 and are using that feedback to draft the new code.

A draft report will be presented to the public in January, and we expect to have the first full draft complete by March.

#### ***Downtown Reconstruction Wrapping Up***

The two-year, \$11 million Downtown Reconstruction Project is scheduled to be complete in January, weather permitting. Most recently, crews have taken out old traffic signals and completed the installation of foundations for new traffic signals at the intersection of LBJ and University Drives and are continuing work on driveways, sidewalks and drainage features.

The completed project will make Downtown a more pleasant experience for pedestrians—come visit the unique businesses and finish your Christmas shopping with local stores!

#### ***New Leadership***

I'm proud to welcome Kristi Wyatt, our new Director of Communications and Intergovernmental Relations, to the City team. She takes the helm of our communications efforts on Jan. 12.

Kristi comes to us from League City, where she worked for seven years and served as the communications director for four. Before joining the Communications Department in League City, Kristi was a television news reporter and producer. In League City, she oversaw an innovative, new-media savvy communications department in a fast-growing city, and we're excited about the energy and experience she'll bring to San Marcos.



We have two more executive level positions to fill early in the coming year: Director of Planning and Development Services and Library Director.

Next year will be just as busy at 2014, if not more so. I look forward to the opportunities the coming year will bring and ask you to continue your support and guidance to us at the City of San Marcos.

## **Extra Bush or Yard Waste?**

Don't forget that if you have extra brush or excess yard waste that does not fit inside your compost cart, city residents can take all yard waste to the drop off at 750 River Road (behind the Animal Shelter) 8 am to 1 pm on the second

Saturday of every month. Bring your utility bill for proof of residence and unload your material. Mulch is also available.

## **Take Me Home Pet Adoption:**

For just \$20 the "Take Me Home Pet Adoption" is available from the Animal Shelter at 750 River Road through December 31<sup>st</sup>. The reduced adoption fees will include sterilization, rabies vaccination, de-worming, general health check, microchipping, and testing for Felv/FIV for cats or testing for heartworms for dogs. Best of all, the cats and dogs adopted during the Take Me Home Adoptions will be able to go home immediately with their new families.
