# ARTICLES OF INCORPORATION

### WILLOW CREEK HOMEOWNERS ASSOCIATION, INC.

MAY 13 1987

We, the undersigned natural persons, at least two (2) of whom are citizens of the State of Texas, and who are of the age of eighteen (18) years or more, acting as incorporators of a corporation under the Texas Non-profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

#### ARTICLE ONE NAME

The name of the corporation is Willow Creek Homeowners Association, Inc..

#### ARTICLE TWO NONPROFIT CORPORATION

The corporation is a nonprofit corporation.

ARTICLE THREE
DURATION

The period of its duration is perpetual.

#### ARTICLE FOUR PURPOSES

The purposes for which the corporation is organized are:

- 1. The specific and primary purpose is the organization of members for the promotion of the health, safety and welfare of the property owners and residents of Willow Creek Estates, a residential subdivision located in Hays County, Texas
- 2. The general purposes are: to provide a vehicle through which funds can be raised to aid in achieving the organization's primary purpose; to provide a forum for discussion of member's problems relating to residence in Willow Creek Estates; to provide a vehicle for public expression of the view of the majority of the organization's members; to encourage social exchanges among neighbors; and to provide an organization through which members can elect to perform civic and charitable activities.
- 3. Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

This corporation is organized pursuant to the Texas Non-Profit Corporation Act and does not contemplate pecuniary gain or profit to the members thereof and is organized for non-profit purposes.

#### ARTICLE FIVE INITIAL REGISTERED OFFICE AND AGENT
