

#### WCHOA Annual Meeting:

#### Oh Dear! The Deer Are Everywhere:

Big ones. Small ones. Short ones. Tall ones. And this year there seem to be more fawns than ever. So please drive carefully – whether it's your car or lawnmower.

When the fawns are very young, mothers temporarily leave them in high grass, which serves as protection. But don't attempt to pick up the fawns or move them. The mothers get very aggressive if they think the fawns are in trouble and may attempt to butt you when you don't expect it. As the fawns get a little bit older and a little bit bolder, they often race through the neighborhood and run out into our streets, heedless of traffic, creating

hazardous conditions – for you and the deer.

If a deer and your car connect – often because a deer runs headlong into your vehicle – call San



Marcos Animal Control immediately, at 512-805-2655. If it's after hours, a weekend or a holiday, you may have to contact the local police department or sheriff's office.

We understand that there are partisans on both sides of the deer issue. Some welcome them. Some don't.

While you may enjoy feeding the deer, attracting them to your property by setting out food can make your neighbors' yards virtual salad bars as groups of deer—often a dozen or two—amble through other yards on the way to yours, and enjoy the roses and other flowers, vegetables, herbs, and other plantings that serve as appetizers on their way to the main course served up in your yard.

And, as many of us have learned after dropping a bundle at the garden center, deer-resistant is NOT the same as deer-proof. With last month's steady rains, everything is green and the deer have plenty to eat so they do not need additional snacks.

Bottom line? Please be a considerate and thoughtful neighbor. That's what makes our neighborhood special.

#### Annual Garage Sale:

The April Garage Sale was a smash hit. We had 31 homes participate—an all-time high. It's a great way to clean out closets and the garage. Participating residents receive ad, newspaper, web site, and email notification support. A few tips for holding a successful garage sale: Items should be clearly marked, properly displayed, and freshly cleaned. Be willing to bargain or mark the item non-negotiable. Be ready to start early in the morning even though the sale starts at a publicized time since veteran treasure hunters often start when dawn breaks. If many items are for sale, then more than one person should help manage the sale. Have change handy to close the sale quickly. These simple guidelines ensure success. A good thing to remember is that leftover items can be donated to various local charity services.

#### Welcome to our New Residents:

We're glad you are here! Some basics about our neighborhood: Deer eat almost anything. Any plant is subject to deer munching unless encased by rabbit fence.

Some residents use dogs to keep the deer "at bay." However, almost nothing works every time over a long time period. Be realistic about your expectations. If you plant roses without a fence, the deer will eat them. Esperanza, palm trees, lantana, salvia, and oleander are about the only plants deer will not eat. Everything else is subject to being eaten, including cacti. If you decide to install a fence or make other exterior modifications to your property, please <u>contact WCHOA to request permission in</u> <u>accordance with your deed restrictions</u>. We will review your request, the design, materials and setbacks and will respond.

### Activity Center:

The San Marcos Activity Center at 501 East Hopkins is the life center of San Marcos (adjacent to the Library). You can sign up for a year or single use. They have a pool, weight room, and racquetball court. The membership fees (annual fees) are super cheap for senior citizens and individuals. Single use fees are a steal. The Center opens at 6 a.m. Monday thru Friday, at 10 a.m. on Saturday and is closed on Sunday. Since it is summer, let's sweat out the carbs at the Center!!

#### Spiffy Neighborhoods:

Our property values depend on us—all of us keeping the lawns mowed, the trash picked-up and cleaning up grass clippings that you blow on to the street when cutting your lawn make our neighborhood look well kept. It doesn't take much effort to keep things looking great. Natural areas are wonderful as long as weeds are kept in check and the area is cleared back about 20 feet from the street. Remember that neat lawns and spruced-up flower beds add value to your property. Be patient when your lawns grow ever so slowly.

Remember this is the Hill Country. The "flora" of the area is fragile since the top soil is very thin. It takes years to replace what is lost after grading or excavation. If new top soil is brought onto the lot, make sure it is good top soil—and "local" top soil. If you bring in top soil from other areas, it may not support the local greenery. Staying as close to the Hill Country "normal" flora and soil is important for the long- term health of your yard. So dig out the stickers and encourage the right vegetation to grow.

## Golf Carts:

A number of residents have come to us with questions about the authorized use of what are commonly referred to as "golf carts" on public streets that run through our neighborhood.

There are many variables involved, based on the type of vehicle, the streets and roads involved, and applicable city or county traffic regulations.

The best place to start is with the Texas Department of Motor Vehicles' helpful "Off-Highway Vehicles" website:

This website describes the various types of vehicles within this classification and the safety and operational regulations that apply to each of them.

It is worth noting that for a vehicle that is classified as a "golf cart" by DMV, operation on a public roadway is generally only permitted in a very limited number of situations, including transportation of two miles or less between a golf course and the location where the vehicle is usually parked.

Under certain, more stringent conditions including specific mandatory safety equipment and insurance—local jurisdictions may permit the operations of golf carts on certain roadways.

If you have questions on this subject, we refer you

to the experts, the San Marcos Police Department, 512-753-2108, or, if you live outside of city limits, to the Hays County Sheriff's Office, 512-393-7800.



## Household Hazardous Waste:

Collection is open weekly—rain or shine, every Tuesday and Friday, starting at 12 noon until 3:30 p.m. This is open to both city and county residents proof of residency is required. Please check this out—location is the traffic yard, 630 E Hopkins, San Marcos. This is a drive-through event—do not exit your vehicles. The list of "will accept" items is quite long. Please check the list at

www.sanmarcortx.govhttp://www.sanmarcostx. gov/index.aspx?recordid=3687&page=102 before making a trip. Both the City of San Marcos and Hays County are reaching out to local residents to make sure they have the info they need to make a decision. Use the resources that are available.

## The USPS Annual Food Drive:

The US Postal Service's annual Food Drive in May nearly doubled donations from previous years.

The letter carriers picked up food at mailboxes and the Hays County Food Bank was the happy recipient. Whether the donation was a single can



of non-perishable food or a hundred items, all donations were appreciated. Some of our residents dropped off items at the local post office—so thanks to all! Remember this national food drive happens every year, so mark May 13 on your 2017 calendar for next year's event.

The Hays County Food Bank usually posts what types of food they need so check out their website before you shop. Their website address is <u>haysfoodbank.org</u> or call them at 512-392-8300. You can also designate them as "your charity" on Smile Amazon (smile.amazon.com). A percent of every dollar spent from your account on Smile Amazon will be sent to the Hays County Food Bank. Amazon will also ship directly to the food bank. Their current wish list includes, rice, green beans, peanuts, canned ravioli, canned peaches and pears, granola bars, peanut butter, canned tuna or chicken. They always need volunteers too.

### Critter Watch:

Watch out for scorpions, snakes and spiders!



Did you know that Texas

has 18 different species of scorpions? And because of the recent rain, numerous snakes, including rattlers and corals, are making the rounds. Yes, there are good snakes and then there are those that will send you to the hospital. Whenever you have a snake encounter, you may not have enough time to determine if it's a "good snake" or otherwise.

Rattlesnakes and coral snakes ("red against yellow kills a fellow") have been sighted and dispatched by some of our neighbors. We often react quickly and may not be able to determine whether the snake is benign. So, what tools can we use to educate ourselves to make that split second decision? Here is a link which will show you what the "good guys" look like: www.poisoncontrol.org.

The same web site has the skinny on scorpions and fire ants – and more. Please watch out for them, too, since they're everywhere.

Our Texas Scorpions seek shelter inside and outside the house and garage. They can hide under pet dishes or trash



baskets. They get into shoes, stacked papers, backpacks, pans, etc. They know no limits. But they do like water and they do like shade.

So before you put on your clothes, shake them out and check your shoes. The last thing you need is an extremely painful and potentially dangerous allergic reaction.

Use the same approach with fire ants. Never wear open shoes in the yard or do garden work without gloves. A single fire ant will sting repeatedly. Putting cornmeal in ant-feeding areas or on the ant hill itself can help with eradication and can show results within a few days of application. But be very careful when you do anything involving fire ants: folks who are allergic, have been rushed to the hospital with only a few stings.
